Planning a Vacation? Remember that the Platte County Sheriff's Department will conduct periodic property checks while vacationers are away. Just contact the Sheriff's Department (816-585 -3521) or www.plattesheriff.org) to provide your property location and vacation dates.

Reminder on Restrictions – If you are thinking about adding an unattached structure or outbuilding (shed, etc.) or putting up a new fence, please contact the association office to make sure your plans are not in violation of restrictive covenants in your area. Permanent or regular parking of campers including travel trailers and RV's, boats and/or boat trailers, non operable vehicles, commercial vehicles or trailers, and any other equipment that detracts from the neighborhood is a restriction violation.

Not all properties in Walnut Creek are subject to restrictive covenants. Please check with the Association Office if you are unsure about your property.

Platte County Serves its Senior Citizens

Platte County in 2016 was rated as the number one county in Missouri in Quality of Life. One of the areas contributing to that rating is services for seniors 60 years of age or older. There are two agencies in the county that provide those services.

Platte Senior Services, Inc. was organized in 1982 as a not-for-profit offering nutrition services (Meals on Wheels and congregate meals), transportation and to operate a five-day-a-week senior center. Amenities at the center include exercise, line dancing, games, entertainment, tax help, information and referral, and volunteer opportunities. PSSI has part-time senior centers in Weston and Dearborn.

Recognizing that "There is no place like home" the Platte County Senior Fund was established in 1994 to provide services to keep seniors in their own homes as long as possible. On a cost share basis services include homemaker, personal care, respite care, minor home repair, Lifeline and transportation for medical, dental and business as well as limited grocery shopping.

Association January Meeting Highlights

The January Community Meeting was called to order by Ken Emerson, Board President, at 7:00 pm on Thursday, January 12, 2017 at the Walnut Creek Clubhouse.

Board Members in attendance were Joe Blount, Joe Bichler, Ken Emerson, Ken Finke, Alex Hodges, Mike Howell, Phil Latessa, and Siobhann Williams. Board Member Scott Eiken was unable to attend.

Ken Emerson welcomed new Board Member Siobhann Williams to the Board. A community member commented on the darkness of the clubhouse parking lot. It was explained that the Board is currently working on adding lighting to the parking lot and converting existing outside lighting to LED.

The Board approved minutes for the December, 2016, Board Meeting.

Old Business:

Board Members approved a request for continuation of privilege suspensions for those violating restrictive covenants. As of January 12, only three (3) members have privilege suspensions.

Joe Bichler reported he had talked to some of the homeowners affected by storm water runoff in the area bounded by Raintree Court, Raintree Drive, and Verlin Drive. There seems to be very little interest in participating in the cost of a Storm Water Control System. Without affected community member involvement and financial participation by all those affected, the Board will table discussion of a Storm Water Grant.

Mike Howell reported two additional contractors have visited and looked at the clubhouse, tennis court, and pool outside lighting. They are preparing cost estimates. *Continued on page 4*

Mike Howell also reported that the broken clubhouse window has been replaced. The Administration Committee reminded Board Members of the need to provide committee action reports to the office in compliance with Missouri Statutes for Non-Profit Reporting. The Administration Committee reported that the TOPS / QuickBooks conversion is underway and close to completion. No additional costs have been identified so the project is expected to be finish within the Special Project Request amount. Sherri Smith provided updates on the conversion details and progress. Mike Howell talked about the formation of a Walnut Creek Social Committee. A list of prospects has been prepared and Board Members were asked to provide additional suggestions of members to add to the list. An article regarding the Social Committee will appear in the upcoming newsletter. New Business: **BOARD MEETING** Ken Emerson reminded Board Members of the importance of getting their committees together ARE HELD to plan for 2017 and to include Community Members who have indicated interest in helping with the various areas. THE SECOND Phil Latessa proposed the 2017 Social Calendar for our traditional community events. The calen-THURSDAY OF dar was discussed and approved by the Board of Directors. The calendar will appear in the upcoming newsletter. EACH MONTH Committee Reports: AT 7:00 PM Administration reported that the 2017 Directors & Officers / Employers Liability Policy has been renewed without a cost increase over 2016. AT THE Clubhouse reported planned repairs to the wood floor in the clubhouse and the need to block off one weekend towards the end of February for the work to be done. CLUBHOUSE. Community Relations reported on the results of the Christmas lighting contest. The results will be SEE YOU THERE! included in the next newsletter. Finance reported that the 2015 Accountant Compilation Report should be finally completed within the next few days. Grounds reported on the status of pond maintenance analysis and the Little Library to be installed in early Spring. Pools reported they will be getting together to plan for the 2017 pool season - hiring of manager (s), assistant manager(s), and lifeguards, etc. The Community Meeting was adjourned without objection. Board Members in attendance were Joe Blount, Joe Bichler, Scott Eiken, Ken Emerson, Mike Howell and Siobhann Williams. Board Members Ken Finke, Alex Hodges, and Phil Latessa were unable to attend.



Association February Meeting Highlights Continued

Community member Joe Smith provided thoughts to the Board on a number of topics including the School Bond proposal on the April election ballot, values of Platte County senior services organizations, concerns about the escalating prices of utilities, observations about the appearance of some of the properties in the community and the benefits of having more information about the demographics of our neighborhood.

The Board approved minutes for the January 2017 Board Meeting.

Old Business:

Board Members approved a request for continuation of privilege suspensions for those violating restrictive covenants.

Mike Howell reported that letters have been sent to selected homeowners and an article was placed in the Jan / Feb Newsletter regarding formation of a Social Committee. At the time of the Board Meeting, two (2) members have responded with interest in participating on the Social Committee.

Mike Howell reported an additional bid has been received for the additional parking lot light and conversion of outside pole lights to LED. Another bid is expected within a few days.

New Business:

The Administration Committee proposed a change to the Rules & Regulations reflecting the increased dues assessment for 2017. (All changes to the Rules & Regulations must have Board approval.) The proposed change was approved by the Board.

Ken Emerson provided Board Members with his cash flow projections for 2017 and discussed some of the methods for developing the cash flow report. Siobhann Williams asked about budgeting for Special Projects. Since no Special Projects have been approved for 2017, Special Projects are not included in the 2017 budget at this time. As Special Projects are approved, additions to the overall Association Budget will be completed. Williams suggested developing an overall list of potential projects Board Members feel need to be considered.

Mike Howell presented a Town Hall Meeting idea to the Board of Directors to provide another outlet for community members to learn about issues / topics that affect the Walnut Creek community and to have another forum to ask questions about Homes Association operations. The Board supports the concept and discussed the best time to offer this type of session. The first 2017 Town Hall Meeting will be scheduled for a Sunday afternoon in late March or early April. The Town Hall topic is planned to be a Realtor Roundtable with Realtors available to provide suggestions of how to keep property values up in our neighborhood and how to project those efforts to the outside world.

Joe Blount proposed the Board continue supporting the Swim Team in 2017 by continuing our swim team scholarship program which subsidizes fees for new first time Walnut Creek swimmers and a lesser subsidy for returning second year swimmers. Costs for these subsidies have been partially offset by non-member fees for swim team swimmers who do not live in Walnut Creek. Based of the success of these subsidies in the past two (2) years, the Board of Directors approved continuing the program for 2017.

Administration – Updated the Board on the TOPS / QuickBooks conversion, Restrictions / Ordinance Enforcement Activities and other plans for 2017.

Clubhouse – Work is being done to repair and rejuvenate the wood floor and the remainder of the clubhouse inside lighting has been converted to LED fixtures. The front doors and back windows are being evaluated as to need for replacement. Ken Emerson will be contacting the Sewer District regarding changes in sewer bill calculations.

Community Relations - No report.

Finance – the 2015 Accountant Compilation Report has been approved and we are awaiting final copies. Tax information to 2016 is being prepared for submission to our accountant.

IF YOU ARE AGrounds – Vendors have been approved for the major grounds maintenance issues. Projects are
underway to identify: a better way to secure the Porta Potty at the park; current problems and
needs for playground equipment replacement; a solution for park trail fencing, erosion control,
storm water drainage and ongoing maintenance for the trail at the park; ball field maintenance and
utilization.

AND HAVE NOT Pools – Efforts to staff the pool operations for the summer and needs for repairs / updates to the pool and surrounding area for the 2017 season are underway.

The Community Meeting was adjourned without objection.

The Walnut Creek South Homes Assn is looking for Assistant Managers, and Lifeguards for the 2017 Pool Season.

Candidates for the management positions:

- Must be at least age 21 by May 15th, 2017
- Must have scheduling experience
- Must be able to enforce all pool rules as stated by the WCSHA board and WCSHA By-laws
- Prior pool or recreation facility experience preferred but not mandatory

Candidates for lifeguard positions

- Must be at least age 15 by May 15th, 2017
- Must be able to swim 500 yards non-stop
- Must be able to pass lifeguarding and CPR courses
- Must be able to follow and enforce all pool rules while on duty
- · Prior lifeguard experience preferred but not mandatory

Training for all positions will be provided at no cost to the applicant.

All applications will be available to be picked up at the Walnut Creek Clubhouse, 5502 Clubhouse Cove, Parkville, Mo during regular office hours. All applications must be returned completed to the Walnut Creek Clubhouse no later than March 30th to be considered for the positions. Applications for Management positions must include a resume of previous experience. Lifeguards wishing to return must complete a new application.

Springtime - What to do ??

What to do with days like these? If you're anything like our family, it is time to get outside! 70's in February and March, have to be taken advantage of! But what to do in the garden?

There's plenty! Water, clean out leaves, turn the compost, you can even till the beds and start your crops. Now is a great time to feed the birds, and the worms too. We use our brewed coffee grounds as a top dressing, or tilled in, to feed the worms.

Happy worms equal happy dirt and that equals happy plants.

Now is also the time to clean and sharpen tools. Four easy steps and about ten minutes will save most pruners. Step one, scrub clean with a wire brush; Step two, file the blade along the bevel; Step three, bleach in a 1 to 10 solution; Step four, spray liberally with wd40, then wipe off the excess. Restoring shovels is a bit more heavy duty, requiring eye wear, an angle grinder, and a vise, but hey it's fun! Safe-ty First, secure your shovel, then grind away rust, dirt, sharpen; wipe with a little oil and you're fin-ished.
