## Member Dues Increase Consideration

In each of the past 3 or 4 years, the Board has considered the need for a member dues increase to support the ongoing operating expenses and maintenance needs of our community. Each year, the Board elected to postpone an increase.

Based on the trends of increasing operational costs, continued needs to maintain our assets, and the need to sustain Association financial reserves, The Board is strongly considering a dues increase to be effective in 2017.

Although the decision to sustain or raise membership dues rests solely with the Board of Directors, we strongly believe it is our responsibility to communicate with and listen to the concerns and opinions of our members.

The following dates and times are opportunities for you to hear about and discuss the potential dues increase at the clubhouse:

September 8, 7:00 - 8:30 pm The initial portion of the Board Meeting will be dedicated to providing dues increase information

September 15, 7:00 - 9:00 pm Town Hall style discussion.

September 17, 3:00 - 5:00 pm Town Hall style discussion

## Facts Relating to Consideration of a Dues Increase

The last Walnut Creek member dues increase occurred fifteen (15) years ago. The past and current Board of Directors have worked hard to manage finances and provide for operating expenses, special project maintenance and improvements, and sustain cash reserves for Association solvency.

Based on the total Association budget for the last five years, 56% of Association revenues are spent on trash pickup (32%) and pool operations (24%). This leaves 44% of revenues available for supporting all of the remaining activities of the Association including grounds, clubhouse, utilities, insurance, accounting, legal, community activities, communications, administration, and all nonreoccurring maintenance and improvement expenses.

Despite cost control efforts, operating expenses continue to increase – during the past 5 years at a rate of over 2.6% each year. In addition to the ongoing operational expenses, the Association must be financially prepared to provide for periodic large-ticket repair / replacement items (furnaces, air conditioning, pool issues, etc.)

In 2015 and again in 2016, the expenses will exceed the revenues of the Association. These overages are funded through our cash reserves. If the Board does not enact a dues increase for 2017, Association cash reserves will continue to reduce diminishing the Association's ability to maintain and support our assets and activities.

Walnut Creek is a long standing community with great amenities for members and their families. It is extremely important to continue the work and expenditures to properly maintain, improve, or replace these assets as needed.

The Board of Directors is considering a \$10 per month increase for all members effective 2017. Please take advantage of the scheduled opportunities to learn more and communicate your thoughts to our Board.

## Association July Meeting Highlights

The July meeting of the Walnut Creek South Homes Association was convened at the clubhouse at 7:00 pm on July 14, 2016, by Ken Emerson, Board President. Board members in attendance were Carol Arnold, Joe Bichler, Joe Blount, Ken Emerson, Ken Finke, Mike Howell, Bernice Motts, Alex Hodges, and Phil Latessa.

Member Joe Smith reported that Mark Edward Tredennick, a past resident of Walnut Creek now residing in Austin, Texas, passed away on June 30. Joe also expressed concern about the need for an emergency exit across the old dam for the lower section of Walnut Creek; putting up safety posting in the park area cautioning of rodents and reptiles in the park area after a flooding event; and more transparency on financials including itemizing special projects, listing assets such as CD's and Money Market accounts, and suggested an audit of Association accounting.

Minutes from the June 2016 Board Meeting were approved.

An email list for notification of alerts and reminders is being compiled and should be available for usage in August.

Storm Water Grant reimbursements from Platte County Storm Water Grant Program are being prepared for Phase One of the Rush Creek Cleanup Project and the completed Raintree Project.

Restriction violations have been greatly reduced and most members are cooperating with the restriction enforcement efforts. The Board approved a motion to suspend membership privileges for members failing to comply with restrictions.

County ordinance violation notifications will begin soon. Those with County Ordinance violations will be notified of the violation and requested to make the needed corrections. If not corrected, the violation will be referred to Platte County for additional action.

At the request of a member, the Board is investigating creation of a 'Little Library' near the clubhouse. Additional information needs to be gathered and someone who is willing to 'manage' the Little Library needs to be identified. Further discussion will occur in the August Board Meeting.

Board committees provided reports and updates on current activities with the following highlights:

Plans to improve the conditions of the ponds near Seminole and Indian Hill are underway with expected start in August. (Grounds)

Plans to revise and improve the plantings at the entrances and clubhouse are being developed. (Grounds)

A review and trending of Association revenue and expenses over the last 5 years expenses is being developed. (Finance)

A community outing in the fall at the park shelter house, playground, and ball field is being discussed. (Community Relations)

The annual Luau and Labor Day Pool functions are being planned. (Pools & Community Relations)

The Community Meeting was adjourned by motion, second, and unanimous approval.

## Association August Meeting Highlights

The August meeting of the Walnut Creek South Homes Association was convened at the clubhouse at 7:00 pm on August 11, 2016, by Ken Emerson, Board President. Board Members in attendance were Carol Arnold, Joe Bichler, Joe Blount, Ken Emerson, Alex Hodges, Mike Howell, Phil Latessa and Bernice Motts. Not in attendance was Ken Finke. Minutes from the June 2016 Board Meeting and July 2016 Board Meeting were approved.

A representative from the Red Cross presented information on Red Cross activities and programs to recruit volunteers for various types of Red Cross activities. She agreed to provide information in a format that can be included in our newsletters and website.

Member Joe Smith inquired about restriction violations and the procedure to correct the violations. The pool reduced the hours when school resumed session. He would have liked to have seen the reduced pool hours communicated earlier to the members. Mr. Smith also inquired about the Swim Team Scholarship program that the Association offered to first year resident swimmers.

Swim Team Representatives Stephanie Wickerham and Mary Wissman gave a summary of the 2016 Team season. Mr. Smith offered his past experience to help the Swim Team. The team grew to from 92 members in 2015 to 113 members in 2016. Most importantly, Walnut Creek member swimmers grew from 30 swimmers in 2015 to 42 swimmers in 2016. The overall ratio of resident swimmers to nonresident swimmers grew from 33% (2015) to 39% (2016).

The email list is ready to

start preparing alerts to be sent to residents.

The Storm Water Grant
Funds should be received
soon for the completion of
the first phase of the Rush
Creek Clean-up. The second
phase of the Rush Creek
Storm Water Grant project
has been delayed due to engineering recommendations
which will increase costs.
Further study and investigation is being done.

The Board approved a motion to suspend membership privileges for the few members failing to comply with requests for compliance with restrictions. County ordinance violation checks will begin during August. This effort involves working with Platte County on ordinance violation identification and enforcement.

After investigation of companies that treat ponds, MAC Water has been selected to not only treat the aquatic and vegetation growth on the ponds, but also to provide analysis of strategies to improve the overall conditions of the ponds. Initial treatments will begin in August.

Contacts have not been completed on the 'Little Library' and the discussion was tabled until the Septem-
