Pool Information

A Few Reminders for Pool Season:

Please do not bring your children to the pool if they are ill. When someone gets sick in the pool or has an accident, the pool must be chemically treated requiring its closure for a period of time. Also, for infants and little ones remember tight fitting plastic underwear or swim diapers that prevent leakage are required!

Please remember to bring your pool pass as the lifeguards will require a pool pass for entry. Guests will be required to sign in to enter the pool.

Please do not expect the pool staff to 'bend the rules'. Pool management and lifeguards do their best to make the pool a safe and fun environment for everyone. The staff's job includes enforcing Red Cross safety guidelines and our associations' rules and regulations to ensure the safety of everyone enjoying the pool.

Please review the pool rules with the occupants of your household. The rules can be found in the last newsletter or online at www.wcsha.org.

<u>Pool Parties</u> – The pool may be reserved for private pool parties after normal pool operating hours. The use of Association lifeguards is required for private pool parties. Contact the office for more information.

<u>Back to School Pool Hours</u> – Once school is back in session, the pool will be open on Friday evenings after 4:00 pm, Saturdays, Sundays, and Labor Day Monday. The Pool will close for the season after Labor Day.


