## **Job Opportunities for 2025 Pool Season**

The Walnut Creek South Homes Association is looking for a Pool Manager, and Lifeguards for the 2025 Pool Season.

#### Candidates for the Management position:

- Must be at least age 18 by May 15th, 2025
- Must be able to pass CPR courses prior to start of pool season.
- Must be able to enforce all pool rules as stated by the WCSHA board and WCSHA By-laws
- Prior pool or recreation facility experience preferred but not mandatory

### Candidates for lifequard positions:

- Must be at least age 15 by May 15th, 2025
- Must be able to swim 500 yards non-stop with freestyle or breast stroke
- Must be able to pass lifeguarding and CPR courses prior to start of pool season.
- Must be able to follow and enforce all pool rules while on duty
- Prior lifeguard experience preferred, not mandatory

Certification Training for all positions will be reimbursed to the applicant.
